3. The amounts indicated against each Municipal Committee shall be credited in the Bank Accounts of respective Municipal Committee separately opened for the purpose. The District Accounts Officers concerned will issue an authority to this effect to the State Bank of Pakistan concerned and National Bank of Pakistan / Bank of Punjab as the case may be.

4. The above mentioned scheme was approved by the Divisional Development Working Party (DDWP) Sahiwal in its meeting held on 04.10.2022 on the basis of PC-I/ estimate submitted by the executing agency and subject to the following conditions:-


- This approval does not constitute any sanction to the rates which shall rest with the authority competent to accord Technical Sanction.

- Executing agencies shall ensure that the schemes are in public interest (feasible) and no other executing agency has undertaken the same work in the area.
