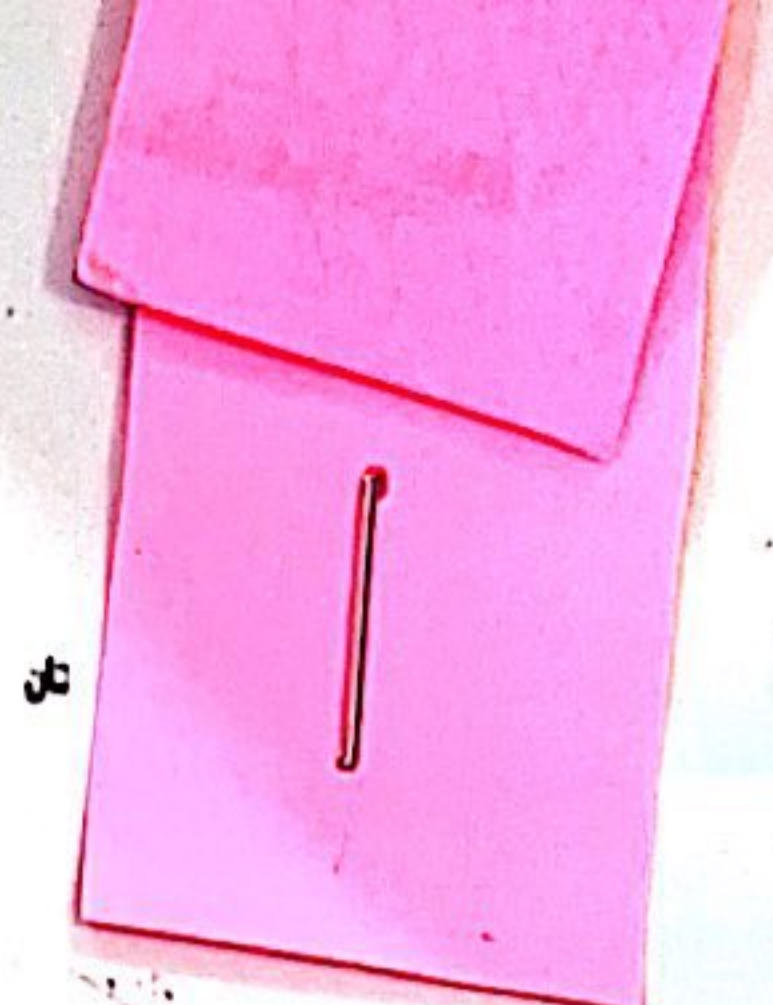


2. The expenditure shall be incurred after observance of all legal / codal / financial and procedure formalities, ensuring compliance of the directions of DDWP and the expenditure involved will be debitable to Grant No.PC21031-Misc, 06-Housing & Community Amenities, 062-Community Development, 0622-Rural Development, 062202-Rural Works Program, LQ4288-Provincial Directorate (LG&CD), A05270-Others, during CFY 2021-22.

3. The responsibility of feasibility, correctness and authenticity of all designs, drawing plans, technology used, calculations, quality and quantity, successful implementation, avoiding any irregularities, lies on the consultants and PMDFC.

4. The amounts indicated against each Municipal Committee shall be credited in the Bank Accounts of respective Municipal Committee separately opened for the purpose. The Officers concerned will issue an authority to this effect to the State Bank of Pakistan concerned and National Bank of Pakistan / Bank of Punjab as the case.

5. The above mentioned schemes were approved by the Divisional Development Working Party (DDWP) Sahiwal in its meeting held on 03.12.2022 on the basis of PC-Is/ estimates submitted by the executing agency duly vetted by the Chief Engineer (North), Punjab Local Government Board, Lahore, subject to the following conditions:-

- i. Depiction of name of MC, Okara in the nomenclature of the scheme reflected in ADP document at GS No.1769 of the ADP 2022-23.
 - ii. This approval does not constitute any sanction to the rates which shall rest with the authority competent to accord Technical Sanction.
 - iii. No change in scope/ enhancement of work as approved by the DDWP would be admissible.
 - iv. The executing agency shall ensure that there is no duplication of work/ payment.
 - v. The executing agency shall strictly observe all the legal, procedural, codal financial formalities including audit requirements & PPRA Rules in letter & spirit.
 - vi. The executing agency shall ensure that the schemes are in public interest (feasible) and no other executing agency has undertaken the same work in the area.
