CONTRACT AGREEMENT

This Agreement made on the 28th day of January 2022, between **Chief Officer, Municipal Committee Okara** (hereinafter called "the Purchaser"), of the one part and **Managing Director of RIKANS** (hereinafter called "the Supplier"), of the other part:

WHEREAS, the Purchaser invited bids for certain Goods (**Supply of Wheel Excavator**) and has accepted a Bid by the Supplier for the supply of those Goods in the sum of **Rs. 36,750,000/- (Rupees Thirty Six Million Seven Hundred Fifty Thousand Only)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be deemed to form and be read and constructed as part of this Agreement, viz.:
 - (a) The Letter of Award of Contract;
 - (b) The Form of Bid;
 - (c) The Bill of Quantities with quoted rates;
 - (d) The Particular Conditions of Contract; Part-II
 - (e) The General Conditions of Contract; Part-I
 - (f) Appendices to Bid;
 - (g) Specifications;
 - (h) Drawings; and
 - (i) Any other Item


This Contract shall prevail over all other Contract documents. In the event of any discrepancy or inconsistency within the Contract documents, then the documents shall prevail in the order listed above.

3. In consideration of the payments to be made by the Purchaser to the Supplier as indicated in this Agreement, the Supplier hereby convenants with the Purchaser to provide the Goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Purchaser hereby convenants to pay the Supplier in consideration of the provision of the Goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.

IN WITNESS the parties hereto have caused this Agreement to be executed in accordance with the laws of Pakistan on the day, month and year indicated above.


