

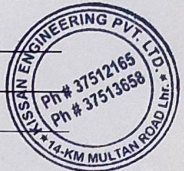

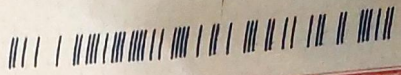

Competent Authority MC, Okara hereinafter called the Competent Authority, MC to execute the following description of work on the following condition:-

- That the contractor is to proceed with the work with due and all the work executed is to be done in a most substantial workman like manner and with material of the good quality and in all cases the workmanship and the quality of the material are to the subject of approval of the Competent Authority or the MO(Infrastructure) of the work and as to the rate of progress, their decision shall be final, the quality of the work executed and of material employed.
- That the contractor shall execute to the work of Provision of Machinery & Equipment for Improvement of Solid Waste Machinery Management in Okara city. of the estimate.
- That the contractor shall complete the work upto _____ or a penalty of Rs. _____ per day shall be charged and recovered from this bill of the contractor.
- In case of bad work being used or bad material being used, that the Competent Authority or the M.O(Infrastructure) incharge of the work may remove the same and have the work or material replaced deducting the material/value of the material or work or cost of the replacement of the same as he may think proper from any amount of due from the contractor.
- In event of the due progress not being used or bad work being done or bad material being used, the Competent Authority or the MO (Infrastructure) may determine and cancel, the agreement with further delay or he may fine to the contractor to the extent of 10% of the work.
- The Competent Authority may determine this agreement at any time and value of the material at site of approved quality and in excess of the requirement of the work in this case, will be paid to the contractor.
- That the contractor shall not sublet the work without the written connect of the Competent Authority.
- The Competent Authority or the MO (Infrastructure) shall have the powers to make additions and alterations to the original specifications, drawings and designs that may appear to him necessary or advisable during the progress of work and contractor shall be bound to carry out the work in accordance with the Competent Authority or the officer incharge.
- That the contractor shall remove from the site of work all material, rubbish etc. to the satisfaction of the officer incharge of the work and clear all dirt that may have accumulated at the site during the execution of work.
- The contractor shall carry out the work strictly in accordance with the P.W.D specifications and time to time, the instruction issued from the MO (Infrastructure) incharge of the work.
- The contractor shall keep a copy of the P.W.D specification with him at the site of work and will show on demand to the officer incharge.
- That the contractor shall refund the amount paid in excess if pointed out by the Audit department at the time of audit checking.
- If the work shall have to be stopped during the progress by the MO (Infrastructure) due to the litigation or any other reason, the contractor shall not claim for any compensation.

Municipal Committee rules and tenders from P.W.D shall be bindings on the contractor.
