The District Accounts Officers concerned will issue an authority to this effect to the State Bank of Pakistan concerned and National Bank of Pakistan / Bank of Punjab as the case.

4. The above mentioned schemes were approved by the Divisional Development Working Party (DDWP) Sahiwal in its meeting held on 17.04.2023 on the basis of PC-II estimates submitted by the executing agency and subject to the following conditions:-

- i. This approval does not constitute any sanction to the rates which shall rest with the authority competent to accord Technical Sanction.
- ii. No change in scope/ enhancement of work as approved by the DDWP would be admissible.

- iii. The executing agency shall ensure that there is no duplication of work/ payment.
- iv. The executing agency shall strictly observe all the codal, legal, procedural, financial formalities including audit requirements & PPRA Rules in letter & spirit.
- v. Executing agencies shall ensure that the schemes are in public interest (feasible) and no other executing agency has undertaken the same work in the area.
