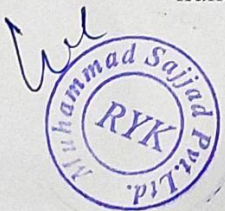

the Firm in shape of Bank Guarantee/CDR in favor of "Municipal Committee Okara" for a period of 03-months.


