The total bid price (herein after referred to as "Total Contract price" shall be governed for the completion of the entire work related to the project, as per terms and conditions set forth in the bidding documents, BOQ, Specifications, Drawings, addendums and the contract of the subject project.

Performance Security of Rs. 43,827,241/- (5% Total Contract price) and Quality Assurance Security of Rs.54,345,779/- (6.2% of the total contract price) shall be submitted by your firm in shape of Bank Guarantee in favor of "Municipal Committee Okara" for a period of 15 months (This Guarantee will be released 07-Months after the satisfactory completion of contract). Failing in



furnishing of Performance Guarantee will result in cancellation of tender and in the event of such cancellation, the entire earnest money / Bid security submitted with the bid shall be forfeited in favor of Municipal Committee, Okara as a compensation for such default.

5. The performance security shall be submitted within **14-days** from the issuance of this letter. The performance security must be issued by a Scheduled Bank operating in Pakistan, as per specimen provided in Bidding Documents.
6. The work shall be carried out by you strictly in accordance with the scope of work as well as other terms and conditions as given in the bidding documents.
7. The Contract Agreement will be executed on **Rs.30,000/-** stamp paper as per specimen provided in bidding documents.
8. All Government instruction and laws/regulations/rules will be applicable.
9. You should also submit your work schedule along with agreement. Timeline shall be strictly observed as per submitted work schedule.
10. If your any document submitted by you is found forge/ fake etc. strict action under relevant clauses shall be initiated against you.
11. You will have to get the quality of material checked and finished work tested by the supervisory staff of Design/ Supervision Consultant (The Engineer) as per his satisfaction and obtain the certificate to this effect. No payment shall be released if the material is not got checked & finished product not got tested finally as per satisfaction of Design/ Supervision Consultant (The Engineer).
12. You are required to execute the work as per provision, scope of work, Terms & Conditions stated in the bidding documents and satisfaction of the Design/ Supervision Consultant (The Engineer) and the undersigned.
13. If the foregoing above are acceptable to you, please sign and return the duplicate copy of this Letter of acceptance in token of your acceptance and depute your authorized representative to execute a formal contract agreement with Municipal Committee Okara, at the earliest please.
